The regular meeting of the Greybull Town Council was held at Town Hall at 6:00 pm with the following members and officers present: Administrator Hunt, Att’y Richins, Mayor Foley, Councilmembers Jolley, Kottman, and Crist, Chief Blosser, and Clerk Carroll. Councilmember Dooley and Foreman Irvine were absent.

Councilmember Crist moved, and Jolley seconded to approve the meeting minutes from January 8th, 2024. Motion carried.

Councilmember Jolley moved, and Kottman seconded to adopt the financials as presented at the previous meeting. Motion carried.

Public Relations:

D. Cooper – Requesting a DE annexation of his property west of Greybull. Att’y Richins described the process for DE annexation for Mr. Cooper and neighbors who were present. No action taken.

B. Gann – Ms. Gann, a representative from CASA, introduced herself to the council in hopes of spreading awareness of CASA’s advocacy in which they speak for children and families in court. No action taken.

Reports:

Administrator Hunt: Her report follows the agenda, and she presented the outcome of the Public Surplus auction items. No action taken.

Public Works: Councilmembers commented that they are very pleased with the new streetlights. No action taken.

Police report: Chief Blosser’s report follows the agenda. Chief Blosser also answered questions regarding the recent drug arrests. No action taken.

Public comment: C. Thomas commented and asked questions regarding the DE annexation requested by D. Cooper. No action taken.

T. Templin also commented and asked questions regarding the requested DE annexation. No action taken.

Additions, deletions, or adoptions: Councilmember Crist moved, and Jolley seconded to add personnel and contract to executive session. Motion carried.

Zoning change – Notice given to start the process of changing the zoning of the KOA Campground from unzoned to RV/Campground.

Tap Relinquishment - approval: Councilmember Crist moved, and Kottman seconded to move forward with the tap relinquishment for delinquent account 1.1500.7. Motion carried.

Request to relinquish tap – Councilmember Jolley moved, and Kottman seconded to start the relinquishment process for delinquent account 1.1280.4. Motion carried.

Unfinished business:

Ordinance #889 – Permanent financing Sewer project: Councilmember Jolley moved, and Crist seconded to approve Ordinance #889 on 2nd reading. Motion carried.

New Business:

Frontier Subdivision Lots 7 and 8 – Councilmember Jolley moved, and Crist seconded to approve the sale of lots 7 and 8 of the Frontier Subdivision. Motion carried.

MC2 – discussion: MC2, a grant company out of Sheridan, will work alongside Administrator Hunt to help with museum grants and further grant training.

Pool – discussion: Administrator Hunt advised that it is time to start thinking about current pricing of pool entry and season passes. Greybull Elks have donated \$1000.00 and there is \$952.00 left over from last season. No action taken.

Planter – discussion: Administrator Hunt reported the difficulty in upkeeping the planter and requests have been made to instead make a buffalo out of painted rocks. The council agreed this would be a good idea, as long as it was done well.

Projects:

Sewer Upgrades Phase 2: discussion: Jake and Mason have completed the final inspection with Rural Development and Wilson Brothers. No action taken.

Main Street Lighting: The streetlights installation has begun. The Greybull Public Works Crew is installing about 5 lights per day. Council members had a brief discussion about what to do with the old lights. No action taken.

Capital Improvement Plan: C. Wyatt is working on documents. No action taken.

WWDC – Level 2 study: Waiting on the final Omnibus bill to be approved through the legislature. No action taken.

MAPS – GIS town – Project is almost completed and only a few meter pits toward Shell are left. The project is progressing as expected. No action taken.

Executive Session – personnel and contract: Councilmember Crist moved, and Kottman seconded to move into executive session to discuss personnel and contract at 6:59pm. Motion carried.

Councilmember Jolley moved, and Kottman seconded to move back into regular session at 7:56pm. Motion carried.

Councilmember Kottman moved, and Crist seconded to order warrants to be drawn in payment of the same on the bills payable December 2023. Motion passed. Motion carried.

Carrie,

I spoke with a landowner yesterday concerning encroachments to the levee. He would like to address his property boundary with a retaining wall, similar to the area behind the swimming pool. I explained any modification to the system needs to go through the 408 permitting process, and that needs to be completed by you the sponsor, or that you provide permission to submit on your behalf. (That typically is only recommended if working with an engineering firm, not necessarily a landowner.) I explained the permitting request is pretty rigorous and not fast. The submittal would need to have a clear plan and drawings. I noted this kind of structure is not unheard of, but also may not be feasible. I am not the one to authorize or deny the project, hence this is why I am relaying information to you.

Section 408 Process

Published Sept. 7, 2018

Background

The US Army Corps of Engineers (USACE) Section 408 policy, contained in the document Engineer Circular (EC) 1165-2-220 effective starting September 10, 2018, sets forth the process and criteria USACE uses to review requests to alter USACE Civil Works projects. For example, communities may want to alter existing USACE projects to increase recreational opportunities or improve flood risk management. Section 408 also applies if a business or utility company seeks to run power lines or pipelines over or through a USACE project. The purpose of a Section 408 review is to ensure that the Congressionally-authorized benefits of a USACE project are not undermined by an alteration made by others, and to ensure the alteration is not injurious to the public interest (e.g., flood risk management, coastal storm damage reduction, navigation).

Benefits of the Section 408 Process

The benefits of the Section 408 process include:

- Provides a mechanism for others to alter an existing USACE Civil Works project without seeking reauthorization of the project from Congress.
- Provides a consistent approach across all Civil Works projects for evaluating and documenting alterations.
- Provides a process to help ensure that existing Civil Works projects continue to deliver the public benefits for which they were authorized and constructed.
- Ensures compatibility of new infrastructure with existing Civil Works projects.
- Ensures that alterations to USACE projects do not have unintended negative impacts to the public.

Improvements to the Section 408 Process

Based on lessons learned over the past few years and comments received on the draft of EC 1165-2-220 (provided for comment in February 2018), USACE improved its Section 408 process to include:

- Delegation of all decisions from Headquarters.
- Authority for District Commanders to further delegate Section 408 decisions.
- Refining and limiting what activities must be reviewed under the process set forth in EC 1165-2-220 to the maximum extent possible, including better clarifying that operation, maintenance, and repair activities by non-federal sponsors do not require Section 408 permission.
- Clarification on the applicability of the process set forth in EC 1165-2-220 to activities in navigable waters, reducing the number of activities that require Section 408 permission.
- Requiring one decision transmittal to requesters for cases when a proposed activity requires both a Section 408 and a USACE Regulatory decision.
- Offering an option for requesters to obtain a Section 408 permission through multi-phased reviews for projects that may require incremental reviews.
- Elimination of the 60% minimum design requirement for Section 408 decisions so information requirements can be scaled to the scope of the Section 408 request.
- Timelines for reviews and notifications in accordance with the Water Resources Development Act of 2016.
- Designation of a lead USACE district for projects that cross multiple districts or states.

Section 408 Tracking Database

Along with improvement to the Section 408 process, USACE has developed a database for tracking Section 408 requests, which will include a public interface to provide the status of requests. The database is currently undergoing testing and will be available for use late calendar year 2018.

ADMINISTRATOR'S REPORT
MARCH 2024**

UNFINISHED BUSINESS

- ORD #889 – Permanent Financing Sewer Project – 3rd reading – we are waiting on final numbers from Wilson Brothers so the 3rd reading isn't ready. Table until the April meeting.
- ORD #890 – Bidding requirements – 2nd reading – State of Wyoming revised the bidding requirements effective July 1, 2023. Town of Greybull ordinance 3.08.010 is related to the previous state statute and hasn't been updated. Rather than have an ordinance that we need to keep up to date we will eliminate and refer to state statute at all times.
- ORD #891 – Buffer zone – **Discussion** – Town of Greybull is adopting the ½ mile buffer zone as allowed by state statute. This isn't to zone anyone within the ½ mile buffer zone nor tell them what they can and can't do on their property. This is being transparent with the state statute that in the event a health and safety concern arises from a NEW development within that buffer zone the mayor may issue a letter expressing the town's concern with the proposal.
- ORD #892 – Misdemeanor offenses – 2nd reading – Town of Greybull can issue any misdemeanor offense into municipal court without this ordinance but to clear things up within administration we are adopting this ordinance.
- Pool – Do we want to review rates or keep the same as last year? We have \$952 in gate fees paid last year that will carry forward this year. Depending on the weather it may or may not cover the June fees. Last June we had 1,078 kids come through the gate. The ELKS has donated \$1,000. Greybull needs a pool is going to continue with same as last year in that businesses will be covering for kids to swim free.

NEW BUSINESS

- Big Horn Basin Geoscience Exhibit Agreement – for review and discussion/approval
- Shell Town Water Improvement District – The town has been approached by the STWID board for possibly taking over their water system. I have forwarded the WWDO level 1 study for you to read. Dave Bottel and Carla Mowell are in attendance for any questions you may have.
- Frontier Subdivision – Lot 4 – under the 25% discount the sale price will be \$25,650
- Frontier Subdivision Lot 18 & 19 approve sale – 1 lot was remaining under the 25% discount. Both lots are the same size so Lot 18 with the discount the price would be \$25,515, the other lot with no discount would be 34,020, Total sale price for both lots is \$59,535. Bidder placed a bid for \$52,000 which amounted to roughly a 22% discount on Lot 19. Council willing to accept the bid?
- Ordinance #893 – KOA zoning – 1st reading – the final piece of zoning the KOA appropriately.
- ORD #894 – Jailable offenses – 1st reading – after meeting with the town attorney and judge we are continuing to clean up our ordinances. A lot of offenses had jail time associated with them that didn't justify that. With jail time the town has possible additional costs of a public defender and jail costs. We didn't eliminate all the jail sentences, but I took the advice of the attorney and judge on the ones we did eliminate.
- Old light poles – Cash Duncan with Big Horn County Fairgrounds is inquiring about getting 40 of our old light poles. Would council like to sell them? Cost? Or donate? After the project is finished we will have 92 poles laying around.

- WAM voting delegate – would anyone like to attend the WAM conference in Pinedale June 5-7, 2024?
- Short-term rental application – our 2nd short term rental application which has been approved with conditional use. Moving over to this process for the short-term rentals.
- Greybull Recreation District – request to use the ball field parking lot for the circus on July 8, 2024.
- Police Department – received 2 letters that I think are worth sharing
- Trees/sidewalks – we have a few areas of concern regarding sidewalks in poor shape that create a hazard. See ordinances in packet relative to this issue. Would council like public works to pursue these hazards?
- Chip Spreader – After receiving low bid on public surplus I reached out to the company we originally purchased the chip spreader from. He stated he can take it back to his business and sell it, wanted to know the absolute lowest price the town would take for it. We paid \$71,000 in 2019 and it hasn't been used. He stated that this was build for the town's specs and he wasn't sure how easy it would be to sell and we wouldn't get anywhere near that price.
 - We have also had an inquiry from someone local willing to purchase the item for \$25,000.
- Budget workshop – need to have a budget workshop so our first reading will take place in April. Does March 18 or March 26 work?

PROJECTS

Sewer Upgrades, Phase II Project

- Submitted all updated paperwork to USDA and locked in the interest rate @ 1.75%
- \$1,080,000; \$811k USDA loan, 169k grant, \$100k town contribution
- Interim Financing with Security State Bank approved.
- SLIB grant application has been submitted – applied for \$780,000 which represents 70% of the total cost of the project at its last estimate. If approved for the full grant amount the town would need to only cover 30% or roughly \$335,000.
- SLIB board meeting will be on October 27th to review all applications.
- Oct 27 SLIB board meeting town was awarded \$780,000 grant. Jake is gathering bid documents and expects this project to go out to bid in soon with project start around March or April.
- DEQ issued permit.
- RD approved bid documents.
- Bidding due March 13th at 2:00 p.m.
- Engineer recommendation went to RD for their approval – see packet.
- Contract Signed
- Work has started
- Getting close to the finish line
- Jake & Mason did an inspection on 2/8/24; everything looks good, and we will start closing the project out.
- Project is completed the cost come in around \$90,000 less than bid. Working on doing the 41 day advertising to wrap it all up.

Main Street Lighting Upgrade

- We have a WAM Energy Lease, current terms are \$100,000 two-year lease with option to renew four terms, annual payment would be \$10,000/year over 10 years with renewal.
- Applied for a grant from Wyoming Energy Authority but wasn't successful.

- The total cost to replace all the decorative streetlights in town would be approximately \$137,000.
- An energy audit was completed on the current lights with results stating significant improvement in lighting energy use and energy cost reductions. Approximate savings would be about \$1,474 per year.
- WAM requests that we would need to request the funds by June 30, 2023.
- Working with Jason from Acuity Brands on looking at some other lighting options to try and reduce the cost to replace.
- Thoughts on doing the replacement in phases? Maybe replace all of 6th street first and then work on Main Street a block each year until fully replaced?
- A sample should be arriving soon and then we will make a final decision.
- The sample arrived and isn't going to work for the types of poles we have. Jason with Acuity is going to do some research and find some other options.
- New sample should arrive this week.
- The poles that are currently installed are old and not very sturdy. Mounting any type of light fixture on them may not be a good idea. At this point we might be better pulling back and figuring out how to improve everything (poles and lights).
- To replace all the poles and fixtures the cost for the entire assembly is \$2,370/unit. This would put us around \$220,000 to upgrade the entire system. To purchase the light itself would cost \$1,211 per fixture for a total cost of \$110,201.
- Received \$100,000 from WAM for energy efficiency lights – with it being late in budget year James Seckman told me I could move it forward to FY24 budget since it was unspent funds.
- 1st ½ of lights has been ordered – 12-week lead time
- The fixtures have been pushed back until the first week of December, so this has turned into a spring project, possibly a late winter project.
- Project has begun – 1st pole & light were installed by the Wheels Motel, crew is installing more by the day.
- Getting ready to order shipment #2. The poles on Greybull Avenue are in a diamond pattern versus the poles on 6th street. Working on making sure we get the correct layout for Greybull Ave.

Capital Improvement Plan

- Town of Greybull has been awarded \$42,500 in ARPA grant money for the capital improvement plan.
- Working with Jeff Barron at WWC Engineering
- WWC submitted a proposal in February of last year that I placed in your packet for review; Jeff is going to refresh everything since it's been a year.
- WWC cost increased by \$4,000 – made appropriate changes to budget to include this.
- This will start after July
- Working with Jeff Barron on the schedule.
- Have a kick off meeting on October 10th to discuss schedule and goals
- Kick off meeting was held on October 10th – we are working on a survey that will be sent out to the residents of Greybull
- Cody is working on documents

WWDC Level II

- Met with selection committee on October 4th in Cheyenne
- Final approval on November 8th

MAPS – Midwest Assistance Program

- Started working with Lee Allen on getting a good working GIS system for the town – this is at no cost to the town. After completion we can pay an annual fee (minimal cost) to have an online GIS system that public works can continue to build on. I believe this is worth the money and a huge benefit to the town. All curb stops, sewer, fire hydrants are currently being mapped.
- All of town has been completed, working on services East of tank towards Shell along transmission line
- Working on the online database

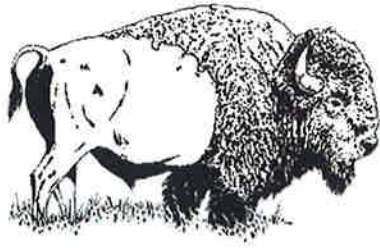

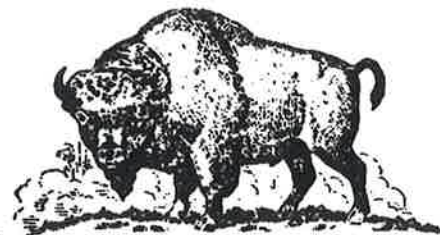



AMERICAN ALLIANCE OF MUSEUM (AAM) NATIONAL STANDARDS AND BEST PRACTICES

AGREEMENT BETWEEN

THE HOST: Town of Greybull. Land and facility owner.

EXHIBIT OWNER: The Big Horn Basin Dinosaur and Geoscience Museum (BHBDGM), a Wyoming non-profit corporation (#2022-001068902) & 501c3 (EIN 87-4538190).

PROVISION OF THE EXHIBIT

- BHBDGM's mission centers on public service by educating, entertaining, and inspiring people of all ages to learn and explore through exposure to iconic dinosaurs and marine reptiles extracted from Big Horn County, and up to this point not permanently displayed in the County.
- BHBDGM is developing and will steward "The Collection" (specific name TBD) with funds from donors under agreement to be made available to the public to create educational, social, cultural, and economic benefits.
- "The Collection" is / will be primarily a set of high-quality Jurassic Period full body casts of scientifically significant dinosaurs of local origin along with professionally designed and presented displays regarding the dinosaurs and the associated paleontological activity and history, and other paleontological items that may be offered for inclusion in "The Collection" by the national museums, or others.
- The U.S. national museums, Sauriermuseum in Switzerland, Black Hills Institute, and other prominent organizations are also offering valuable scientific and exhibit display guidance.
- BHBDGM commits to create, install, maintain, and continue to enhance the exhibit to the standards of the AAM and with the ongoing guidance of the involved prominent museums to ensure the exhibit remains current and scientifically accurate.
- If a suitable facility is not available by the end of the donor campaign (end of 2027) the donor agreement outlines the options available which include extending the timeline if good progress is being made on the facility, seeking an alternate host, selling assets / returning cash to donors, or proposing other options for donor consideration.

PROVISION OF THE FACILITY

- The Town of Greybull wishes to provide its residents and all visitors with access to the benefits that will come from the presence of "The Collection" in Greybull. The primary benefactors are the residents of Greybull and nearby communities.
- Additionally, many thousands of visitors travel through this portion of Wyoming annually on outdoor-oriented adventures. Providing access to such an exhibit provides a high-quality option to visit Greybull, local businesses and to explore this area.
- The Town of Greybull seeks to provide a facility suitable for "The Collection" including lighting, utilities, and general upkeep of the facility.
- BHBDGM will provide for cleaning the building interior and exhibit, internet, and security and will keep all its stored objects and materials properly stored and maintained to AAM standards.

ACKNOWLEDGMENTS, COSTS, AND INCOME DISTRIBUTION

- BHBDGM will provide all ongoing maintenance and enhancement of “The Collection” through donations and possibly subscriptions, entry fees and the sale of merchandise related to the exhibit’s purpose. If income exceeds the ongoing needs of the exhibit on an annual basis, it will either be invested to sustain and enhance the exhibit in the future or will be paid to the Town of Greybull to offset the cost of providing the facility.
- BHBDGM and the Town of Greybull may wish to discuss how to best advertise the exhibit and encourage travelers to visit, such as signage, billboards, and ads. BHBDGM will use its resources to have the exhibit referenced in literature, printed and online material, and social media to encourage visitors. BHBDGM plans to develop iconic artwork as licensed branding for the exhibit, at its own cost, that will be available for inclusion in advertising, whether by the Town of Greybull or the BHBDGM.
- BHBDGM Board members serve without compensation, at their own cost. The Board may offer others in the community the opportunity to join in serving as unpaid docents for the exhibit. BHBDGM may consider, at its own cost, paying for a full or part-time docent or intern.
- In providing the exhibit, BHBDGM may be obligated to ensure its donors, content license holders, national museums, and authors / creators of intellectual property are acknowledged.
- The Town of Greybull in providing the facility and for its operation is making a considerable investment to secure the benefits of this project for the community.

SECURITY AND RISK MANAGEMENT

- The exhibit will be designed to include physical barriers common in such applications to isolate visitors from contact with the exhibit that would normally be a hazard to the visitor or exhibit.
- The industry convention of “wall to wall” insurance is assumed to apply, where the Host may provide all coverages (damage, theft, loss, injury, liability, etc.) and where the Exhibit Owner may provide coverage for loss and damage of its assets.
- BHBDGM presently anticipates obtaining a policy for the value of its own assets, naming the Host and Town of Greybull as additionally insured, but is open to discussion to fit within any framework already in use or preferred by the Town of Greybull.
- The Town of Greybull will provide security and surveillance to protect the facility and building access. The BHBDGM may wish to install additional surveillance to protect The Collection.

AGREEMENT DURATION & MODIFICATIONS

- Owner and Host desire a long-term exhibit of “The Collection” to serve the public as outlined.
- This is the entire agreement, which can be amended with mutual consent of both parties.
- Should Host wish the exhibit to be removed, Owner will have 1 year to comply upon notice.
- Should Owner find it necessary to remove the exhibit, Host will be notified 1 year in advance.



4. Objects when used, advertised for use, intended for use or designed for use in injecting controlled substances into the human body;
5. The following objects when used, advertised for use, intended for use or designed for use in ingesting, inhaling or otherwise introducing marijuana, cocaine, hashish or hashish oil or any other controlled substance into the human body;

- A. Metal, acrylic, glass, stone, plastic or ceramic pipes with or without screens, permanent screens, hashish heads or punctured metal bowls;
- b. Carburetion tubes;
- c. Carburetion masks;
- d. Chamber pipes;
- e. Carburetor pipes;
- f. Electric pipes;
- g. Air-driven pipes;
- h. Chillums;
- i. Bongs;
- j. Ice pipes or chillers.

B. It shall be unlawful to possess drug paraphernalia within the corporate limits of the town.

C. It shall be unlawful to possess any item or instrument used or intended for use for the introduction into the body of a prescription medication if the use of that item or instrument is inconsistent with the medically accepted administration of the medication.

D. A violation of subsection (B) or (C) shall constitute a misdemeanor and is punishable by ~~sentence of not more than six months in jail,~~ a fine of not more than \$750.00, ~~or both.~~

SECTION 1: Section 1.12.020 shall be amended to the Greybull Town Code, to wit:
1.12.020 - Jailable sentences.

A jail sentence of not more than six months in addition to a fine as set forth in such sections, shall, at the discretion of the court, be imposed for the following sections of the Greybull Municipal Code:

Section 2.40.040 – Failure to Appear

Section 9.40.130 – Assault and Battery

Section 9.40.140 – Resisting and impeding an officer

SECTION 2: Section 6.13.070 shall be amended to the Greybull Town Code, to wit:
6.13.070 - Penalties

Whoever violates this chapter shall be guilty of misdemeanor punishable by a fine of not more than \$750.00 and the animal may be confiscated and disposed of.

On behalf of the Greybull Recreation District I would like to request the use of the soccer field and parking lot area at the Baseball Complex as showgrounds for the Culpepper and Merriweather Circus. The Greybull Recreation District would like to host the circus again on Monday, July 8, 2024. An area of at least 300'x300' (which is accessible to large vehicles) is required for set-up. The circus also requests access to potable water and dumpsters for trash, all of which the facility provides.

The Recreation District will be responsible for the contract fee, collecting/selling tickets and ensuring that the restrooms and lots used are clean after the performances. The circus furnishes it's own electricity, equipment and personnel necessary to operate. Culpepper & Merriweather Circus also holds liability insurance in the amount of \$2,000,000 indemnifying the sponsor, lot owner, municipality and the circus.

The circus was last in the area in 2022 and used the parking lot at the Baseball Complex. A total of 671 tickets were sold. The area worked out well, however the wind didn't cooperate and the audience inside the main tent were pelted with dirt and gravel. If approved, the main tent would be set up in the grass on the soccer field, rather than the dirt.

I will be communicating with the manager and would be happy to go up with a member of the town crew to mark any water/sprinkler lines and discuss facility use ahead of time. I will also be present when the circus arrives to direct when/if needed. Thank you for the consideration.

12.04.010 - Responsibility of property owners.

All sidewalks shall be constructed, reconstructed and repaired by the owner or owners or property abutting thereon, and when property owners fail to construct, reconstruct or repair such sidewalks, then the sidewalks shall be constructed, reconstructed or repaired by the town of Greybull at the cost and expense of the owner or owners, and assessed against the property abutting thereon as by law provided.

(Ord. 27 § 1, 1910)

12.04.080 - Service of notice upon property owner.

Whenever any sidewalk is in need of reconstruction or repair, so as to conform to the requirements of this chapter, the council shall direct the police officer to serve notice in writing upon the owner or agent of abutting property, requiring the owner or agent to rebuild or repair such walk within 15 days after the service of the notice, and if the walk is not rebuilt or repaired within the 15 days thereafter, the walk shall be rebuilt or repaired by the town in the same manner and upon the same terms as provided for the first construction thereof.
